PROCLAMATION No. 368

EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 283, DATED MARCH 27, 1956, WHICH ESTABLISHED THE FIRE STATION SITE RESERVATION AT THE CITY OF DAVAO, A PORTION OF THE LAND EMBRACED THEREIN AND RESERVING THE SAME FOR PUERICULTURE CENTER SITE PURPOSE

Upon recommendation of the Secretary of Agriculture and Natural Resources and pursuant to the authority vested

in me by law, I, Ramon Magsaysay, President of the Philippines, do hereby exclude from the operation of Proclamation No. 283, dated March 27, 1956, which established the fire station site reservation situated in the district of Sta. Ana, City of Davao, a portion of the land embraced therein and reserve the same for puericulture center site purposes under the administration of the City of Davao subject to private rights, if any there be, which portion of land is more particularly described, to wit:

*Lot 2-A Psd-48523*  
(Sta. Ana Puericulture Center)

A parcel of land (lot 2-A of the subdivision plan Psd-48523, being a portion of lot 2 of Davao Townsite Sta. Ana Addition, G.L.R.O. Record No.           ), situated in the District of Sta. Ana, City of Davao. Bounded on the W., along line 1-2 by lot 2-B of the subdivision plan; along line 2-4 by lot 2-B of the subdivision plan; and along line 4-1 by 1st Avenue. Beginning at a point marked 1 on plan, being No.  $6^{\circ} 32' E.$  106.02 meters from monument 1, Davao Townsite, thence N.  $5^{\circ} 05' W.$ , 12.50 meters to point 2; thence N.  $84^{\circ} 54' E.$ , 25.00 meters to point 3; thence S.  $5^{\circ} 05' E.$ , 12.50 meters to point 4; thence S.  $84^{\circ} 55' W.$ , 25.00 meters to the point of beginning; containing an area of 312 square meters. All points referred to are indicated on the plan and marked on the ground by P.L.S. cylindrical concrete monuments; bearings true; date of the original survey, June 12 to Aug. 28, 1908, and that of the subdivision survey, September 18, 1956, by Medardo A. Fune, Private Land Surveyor.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
