BY THE PRESIDENT OF THE PHILIPPINES

PROCLAMATION NO. 602

ESTABLISHING AS ILOG-HILABANGAN WATERSHED FOREST RESERVE FOR PURPOSES OF PROTECTING, MAINTAINING, OR IMPROVING THE WATER YIELD AND PROVIDING RESTRAINING MECHANISM FOR INAPPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LAND-USE, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN LOCATED IN THE MUNICIPALITIES OF HIMAMAYLAN AND KABANKALAN, PROVINCE OF NEGROS OCCIDENTAL, ISLAND OF NEGROS, PHILIPPINES.

Upon recommendation of the Secretary of Environment and Natural Resources, and pursuant to Section 18 of the Presidential Decree No. 705, otherwise known as the Revised Forestry Code of the Philippines, as amended, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Ilog-Hilabangan Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, the parcel of land of the public domain located in the Municipalities of Himamaylan and Kabankalan, Province of Negros Occidental, Island of Negros, Philippines, which parcel is more particularly described as follows:

Beginning at a point marked "1" being identical to Proclamation Boundary Monument (PBM) No. 9 of Negros Occidental and Negros Oriental Provincial Boundary;

the point of beginning, containing an area of TEN THOUSAND TWO HUNDRED ELEVEN (10,211.0) HECTARES, more or less.

The Department of Environment and Natural Resources shall administer and manage the reservation, in coordination with other agencies of the government, with the objective of maintaining its usefulness as a source of water for agriculture, domestic and industrial uses, and for other forestry purposes.
