PROCLAMATION NO. 632

RESERVING FOR PROVINCIAL GOVERNMENT CENTER SITE PURPOSES OF THE PROVINCE OF ISABELA, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN BARANGAY ALIBAGU, MUNICIPALITY OF ILAGAN, PROVINCE OF ISABELA.

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from sale or settlement, and reserve for Provincial Government Center Site purposes of the Province of Isabela, subject to private rights, if there be any, a certain parcel of land of the public domain, situated in Barangay Alibagu, Municipality of Ilagan, Province of Isabela, and more particularly described as follows, to wit:

A parcel of land, plan Ap-2-02-000722, which is identical to Lot 8200, Cad. 403, as surveyed for PROPOSED GOVERNMENT CENTER OF ISABELA, situated in the Barrio of Alibagu, Municipality of Ilagan, Province of Isabela, Island of Luzon. Bearings grid; date of original survey on July 28, 1983 and that the survey was executed by Geodetic Engineer Juan P. Ortiz on January 10, 1989 and was approved on April 3, 1989.
