PROCLAMATION NO. 1156

DECLARING JICONTOL WATERSHED FOREST RESERVE SITUATED IN THE MUNICIPALITIES OF MASLOG, DOLORES AND CAN-AVID, PROVINCE OF EASTERN SAMAR, AS A PROTECTED AREA PURSUANT TO REPUBLIC ACT NO. 7586 (NIPAS ACT of 1992) AND SHALL BE KNOWN AS JICONTOL NATURAL PARK

Upon recommendation of the Secretary of the Department of Environment and Natural Resources, and pursuant to the power vested upon me by law, I, **FIDEL V. RAMOS**, President of the Republic of the Philippines, do hereby set aside and declare Jicontol Watershed Forest Reserve situated in the Municipalities of Maslog, Dolores and Can-Avid, Province of Eastern Samar, as a Protected Area under the category of **Natural Park** as described in DENR NIPAS Map No. R08-1:

 implementing rules and regulations.


