PROCLAMATION NO. 324

RESERVING FOR SCHOOL SITE PURPOSES OF MARAGUSAN NATIONAL HIGH SCHOOL A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN, SITUATED IN POBLACION, MARAGUSAN, COMPOSTELA VALLEY PROVINCE, ISLAND OF MINDANAO

Upon recommendation of the Secretary of Environment and Natural Resources, and by virtue of the powers vested in me by law, I, **JOSEPH EJERCITO ESTRADA**, President of the Philippines, do hereby withdraw from sale, entry, disposition or settlement, and reserve for school site purposes of Maragusan National High School under the administration of the Department of Education, Culture and Sports, subject to private rights, if any there be, a certain parcel of land of the public domain situated in Poblacion, Municipality of Maragusan, Compostela Valley Province, Island of Mindanao, and more particularly described as follows:

Lot 143, TS-11-000074-D
(Maragusan National High School)
San Mariano Townsite Subdivision

A PARCEL OF LAND, Lot 143, Ts-11-000074-D, situated in Poblacion, Municipality of Maragusan, Compostela Valley Province, Island of Mindanao.

Date of subdivision survey, December 7-8, 1987 by Geodetic Engineer Leopoldo A. Macabingkil and was approved on February 17, 1988.


