

BY THE PRESIDENT OF THE PHILIPPINES

PROCLAMATION NO.473

RESERVING FOR SCHOOL SITE PURPOSES OF THE BENGUET SCHOOL OF ARTS AND TRADES, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN, SITUATED IN BARANGAY DACLAN, MUNICIPALITY OF BOKOD, PROVINCE OF BENGUET, ISLAND OF LUZON

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, **GLORIA MACAPAGAL-ARROYO**, President of the Philippines, do hereby reserve for school site purposes of the Benguet School of Arts and Trades, a certain parcel of land of the public domain located in Sitio Ambangueg, Barangay Bokod, Municipality of Benguet, Island of Luzon, which parcel of land is more particularly described as follows:

LOT 2826, CAD-932-D, CASE -4

A parcel of land (Lot 2826, Cad-932-D, Case-4) situated at Daclan, Bokod, Benguet, Island of Luzon.
