**PROCLAMATION NO. 1290**

**CREATING AND DESIGNATING THE FACILITIES CENTRE, LOCATED AT 548 SHAW BOULEVARD, BARANGAY HIGHWAY HILLS, MANDALUYONG CITY, METRO MANILA, AS INFORMATION TECHNOLOGY CENTER PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748**

Pursuant to the powers vested in me under Republic Act No. 7916, the Special Economic Zone Act of 1995 as amended by Republic Act No. 8748 and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby create and designate as Information Technology Center, subject to the provisions of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, and Resolution Nos. 00-411 and 06-278 dated 29 December 2000 and 27 June 2006, respectively, of the Board of Directors of the Philippine Economic Zone Authority, the Facilities Centre, which was established on a lot located at 548 Shaw Boulevard, Barangay Highway Hills, Mandaluyong City, Metro Manila, containing an area of **SIX THOUSAND TWENTY THREE (6,023) SQUARE METERS**, more or less, as defined by the following technical descriptions:

**Lot 48 Block 1**  
**Psd-13-004922**

A parcel of land (Lot 48 (commercial) Block 1, of the subdivision plan Psd-13-004922, being a portion of Lot 1-B, Psd-4272, LRC Rec. No. 875, 699 and 917), situated on Barangay Highway Hills, Municipality of Mandaluyong (now City of Mandaluyong), Metro Manila. Bounded on the SW., along line 1-9 by Lots 36 and 43, on the NW., along line 9-10 by Lot 47 (commercial) all of Block 1 of the subdivision plan; on the NE., along line 10-11 by Shaw Boulevard; on the SE., along line 11-12 by Lot 1-A Psd-4272 and on the SW., along line 12-1 by Lot 35, Block 1 of the subdivision plan.

Beginning at a point marked "1" on plan, being S. 89 deg. 13'E., 2322.59 m. from BLLM No. 1, (San Felipe Neri), Mandaluyong;

Except point 11 by OLD PLS cyl. conc. mons; bearings true; date of original survey, July 11 and 15, 1927, that of the subdivision survey, September 24 to October 20, 1987, approved on January 7, 1988.
