**PROCLAMATION NO. 668**

**CREATING AND DESIGNATING A BUILDING AND THE PARCELS OF LAND WHERE IT STANDS, LOCATED AT DONATO PISON AVENUE, BARANGAY SAN RAFAEL, MANDURRIAIO, ILOILO CITY, AS A SPECIAL ECONOMIC ZONE (INFORMATION TECHNOLOGY CENTER), PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748**

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), **I, FERDINAND R. MARCOS, JR.**, President of the Philippines, do hereby create and designate a building, to be known as **The Grid**, with a gross floor area of **Seven Thousand Twenty-One and 88/100 square meters (7,021.88 m<sup>2</sup>)**, more or less, and the parcels of land where the building stands, with an area of **Two Thousand Three Hundred Thirty-Four square meters (2,334 m<sup>2</sup>)**, more or less, as a Special Economic Zone (Information Technology Center), located at Donato Pison Avenue, Barangay San Rafael, Mandurriao, Iloilo City, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, and PEZA Board of Directors Resolution No. 00-411 (s. 2000), as amended by Resolution Nos. 11-066 (s. 2011) and 15-240 (s. 2018), and Resolution No. 20-341 (s. 2020), as defined by the following technical descriptions:
