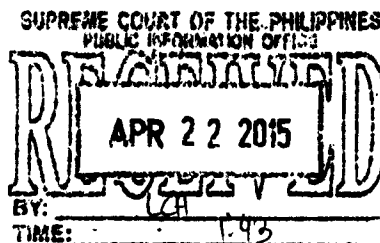

Sirs/Mesdames:

*Please take notice that the Court en banc issued a Resolution dated APRIL 14, 2015, which reads as follows:*

**“G.R. No. 217300 (Froilan C. Tejada, Jr. vs. Commission on Audit).-** In accordance with Rule 64 and other related provisions of the 1997 Rules of Civil Procedure, as amended, as well as circulars, directives or orders of the Supreme Court, governing review of judgments and final orders or resolutions of the Commission on Audit, only petitions which are accompanied by or which comply strictly with the requirements specified therein shall be entertained. On the basis thereof, the Court Resolved to **DISMISS** the instant petition for certiorari for non-compliance therewith, particularly for –

(a) failure to accompany the petition with a clearly legible duplicate original or certified true copy of the assailed December 29, 2014 Decision in violation of Rule 64, Section 5;

(b) late filing as the assailed Decision was served by registered mail and received at the petitioner’s residence on March 2, 2015;

(c) insufficiency of the petition in form as the verification and certification against forum shopping are not under oath as required by Rule 7, Sections 4 and 5, and thus, insufficient or defective;

(d) non-submission of proof of service of the petition on the adverse party (*e.g.*, a written admission of the party served/an affidavit of the party serving/registry receipts) as required by Rule 56, Section 2 (c), Rule 46, Section 3 (3<sup>rd</sup> par.) in relation to Rule 56, Section 2 (1<sup>st</sup> par.), and Rule 13, Section 13;


(e) failure of petitioner to indicate in the petition the number and date of his current Professional Tax Receipt (PTR) and IBP Official Receipt or Life Membership numbers as required in Bar Matter No. 287; and

(f) failure of petitioner to indicate in the petition his contact details, *e.g.*, telephone number, fax number, cellular phone number or e-mail address, as required in the *En Banc* Resolution dated July 10, 2007 in A.M. No. 07-6-5-SC." Leonardo-De Castro, J., on official business. Villarama, Jr., J., on official leave. (adv57)
