
Please take notice that the Court, Second Division, issued a Resolution dated 17 February 2020 which reads as follows:

“G.R. No. 250718 (Heirs of Spouses Abelardo and Francisca Valarao, represented by Francisco C. Geronimo v. MSC & Co., Inc.). – After a judicious study of the case, the Court resolves to **DENY** the instant petition¹ and **AFFIRM** the August 9, 2019 Decision² and the November 27, 2019 Resolution³ of the Court of Appeals (CA) in CA-G.R. SP No. 160524 for failure of petitioners Heirs of Spouses Abelardo and Francisca Valarao, represented by Francisco C. Geronimo (petitioners), to sufficiently show that the CA committed any reversible error in denying their petition.

As correctly ruled by the CA, respondent MSC & Co., Inc. timely moved for the issuance of a writ of execution after this Court issued its June 8, 2016 Resolution in G.R. No. 185331, denying petitioners’ petition for review on *certiorari*.⁴ While an entry of judgment had already been issued by the CA as early as October 15, 2008 declaring the case final and executory,⁵ the writ of execution initially issued by the trial court on January 13, 2009 was subsequently withdrawn due to the pendency of G.R. No. 185331.⁶ This judicial courtesy extended by the trial court effectively suspended the prescriptive period within which to enforce the final and executory decision.
