*Please take notice that the Court, Second Division, issued a Resolution dated **2 September 2020** which reads as follows:*


“G.R. No. 252950 (David A. Lim v. Mary Grace O. Roña, Megaland 168, Inc., and Security Banking Corporation). – After a careful review of the case, the Court finds the petition for review on *certiorari* to be lacking in merit. The Court finds no reversible error on the part of the Court of Appeals when it dismissed petitioner David A. Lim’s petition for *certiorari* for failure to file a Motion for Reconsideration of the Regional Trial Court Order dated 29 April 2019, and for being procedurally infirmed.

WHEREFORE, the Court resolves to **DENY** the instant petition. The Resolutions dated 20 June 2019 and 26 June 2020 issued by the Court of Appeals in CA-G.R. SP No. 161064 are **AFFIRMED**.

With the denial of the instant petition, the petitioner’s prayer for the issuance of a temporary restraining order and/or writ of preliminary injunction is necessarily **DENIED**.
